WHEREAS, on February 25, 2014, the NJ Division of Environmental Protection, Bureau of Safe Drinking Water ("DEP"), noticed the Washington Township Municipal Utilities Authority ("Authority") that on February 6, 2014 a permit was issued for additional chemical treatment of the Schooley's Mountain Water System; and

WHEREAS, as a result of this additional treatment, the DEP upgraded the Water Treatment licensed operator facility classification for the Schooley's Mountain Water System from a T-1 to a T-2; and

WHEREAS, as a result of the T-2 Classification, the Schooley's Mountain Water System minimum operator license increased from a T-1 to a T-2; and

WHEREAS, the Authority Employees Association contract provides for an annual license stipend for each license that is at or below the maximum class license required for the Water System; and

WHEREAS, the Authority approved on July 2, 2014 to compensate David Carswell for the license stipend effective February 6, 2014; and

WHEREAS, David Carswell on March 26, 2014 formally requested the license stipend implemented retroactive to the year 2000; and

WHEREAS, the Authority reviewed the history of the implementation of the T-2 license classification.

ADOPTION OF PERSONNEL POLICIES AND PROCEDURES MANUAL

No. 15-03-E

WHEREAS, the Washington Township Municipal Utilities Authority (the Authority) has insurance coverage through New Jersey Utility Authorities Joint Insurance Fund (JIF); and,

WHEREAS, JIF coverage for Personnel Practices Risk Control is provided through the New Jersey Municipal Excess Liability System (MEL); and,

WHEREAS, MEL requires that the Authority maintain a Personnel Policies and Procedures Manual; and,

WHEREAS, the Authority has updated its Personnel Policies and Procedures Manual and it is ready for redistribution.

NOW, THEREFORE, BE IT RESOLVED by the Washington Township Municipal Utilities Authority, that:

1. The Personnel Policies and Procedures Manual, originally adopted December 2, 2004 and last revised December 30, 2014, attached hereto is hereby adopted.
2. The Personnel Policies and Procedures Manual procedures shall apply to all Authority officials, appointees, employees, and independent contractors. In the event there is a conflict between these rules and any collective bargaining agreement, personnel services contract or Federal or State Law, the terms and conditions of that contract or law shall prevail. In all other cases, the Personnel Policies and Procedures Manual shall prevail.
3. The Personnel Policies and Procedures Manual is intended to provide guidelines covering public service by Authority employees and is not a contract. The provisions of this manual may be amended and supplemented from time to time without notice and at the sole discretion of the Authority.
4. To the maximum extent permitted by law, employment practices for the Authority shall operate under the legal doctrine known as "employment at will."
5. That the Executive Director and the MEL Personnel Administrator are authorized to distribute said Personnel Policies and Procedures Manual to all Managerial Personnel and Sections One through Five of the Manual to all Employees.
6. This Resolution shall take effect as provided by law.

Please follow the steps below to access the program. To receive credit, the program must be completed by June 1, 2015.

Step 1: Go to the MEL's website <http://njmel.org/>

Step 2: On the MEL homepage, click on the MSI logo at the top to access the MSI page.

Step 3: On the MSI page, click "MSI Login" to access the login page.

Step 4: Login to access the Welcome Page. If you have taken MSI classes in the past, enter your username and password. If you do not know your username/password, check with your Training Administrator or call the MSI Helpline listed below. If you are new, click "I am a new user." Complete the fields and you will receive a confirmation email with your username and password.

Step 5: On the Welcome Page, click on "MSI On-line Training Courses" on the lower right to access the course selection page.

Step 6: On the course selection page, click "Employment Practices Liability" on the left. Then click "enroll" on the right.

Step 7: The program will now thank you for enrolling. Hit "Click here" to go to your authorized course list.

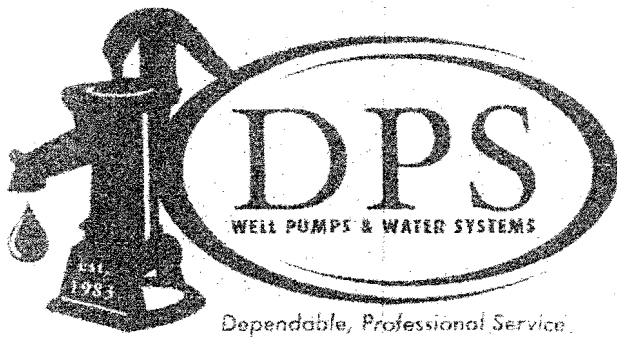

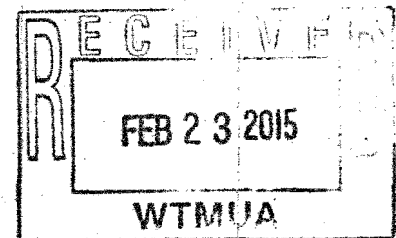

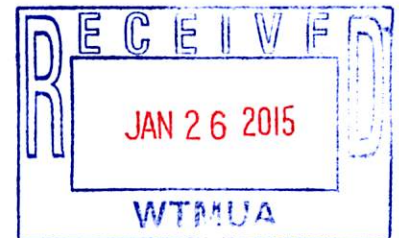

TAKE NOTICE that on **JAN 21 2015**, pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Upper Raritan Water Quality Management Plan (WQMP) was adopted by the Department. This revision corrects and updates the Washington Township, Morris County, Wastewater Management Plan (WMP). Specifically the WMP's text and facility table associated with the Washington Township Municipal Utility Authority's (WTMUA) Schooley's Mountain Sewage Treatment Plant (STP) have been revised to reflect the proposed redevelopment on Block 33, Lot 2 for Mountain View Inn as identified in the Highlands Perseveration Area Approval (HPAA) Health and Safety wavier application (No. 1438-14-0012.1) currently under review by the Department.

The Washington Township, Morris County, WMP was adopted on July 24, 2012. As Washington Township is a Highlands Conforming municipality, the WMP is consentient with the adopted Highlands Regional Master Plan (RMP). The adopted WMP identifies Block 33, Lot 2, as property located within the Highlands Preservation Area eligible for a Preservation Area Health and Safety wavier due to an on-site failing septic system. In addition, to provide for future sanitary sewer connection, the WMP recognized the two existing buildings on this parcel as included within the sewer service area of the WTMUA Schooley's Mountain STP. However, the WMP text indicated that the projected wastewater flow attributed to this parcel, although the exact volume was not available, was estimated at 2,000 gallons per day based on the assumption that one structure housed a 50 seat restaurant and the second building retail florist shop.

The adoption of this revision will allow for the redevelopment on Block 33, Lot 2, in accordance with the requirements of the HPAA wavier, for the proposed Mountain Inn, with an associated 127 restaurant seats and 20 bar seats. The total projected wastewater flow from this redevelopment as calculated in accordance with N.J.A.C. 7:14A-23.3 has been determined to be 4,845 gallons per day. As part of this revision, the WMP text and facility table 8, for the WTMUA Schooley's Mountain STP, has been updated to account for this new flow projection for the redevelopment within this parcel.

As provided under N.J.A.C. 7:15-3.5(b)1.ii, the Department has determined that due to the re-calculation of flow from the parcel, the proposed project activity qualifies as a revision in order to correct, clarify, or update statements affecting development existing at the time of the most recently adopted areawide WQM plan or amendment.

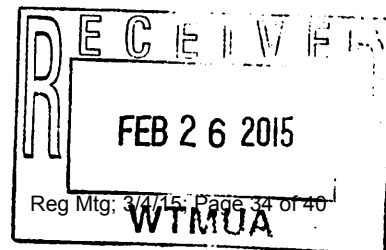

3. That watertight manhole covers must be provided for manholes that may be subject to street flooding or located within a flood hazard area.

GENERAL CONDITIONS FOR TREATMENT WORKS APPROVALS**Section A. GENERAL CONDITIONS**

1. This permit is revocable, or subject to modification or change, at any time, when in the judgement of the Department of Environmental Protection of the State of New Jersey such revocation, modification or change shall be necessary.
2. The issuance of this permit shall not be deemed to affect in any way action by the Department of Environmental Protection of the State of New Jersey on any future application.
3. The works, facilities, and/or activities shown by plans and/or other engineering data, which are this day approved, subject to the conditions herewith established, shall be constructed and/or executed in conformity with such plans and/or engineering data and the said conditions.
4. No change in plans or specifications shall be made except with the prior written permission of the Department of Environmental Protection of the State of New Jersey.
5. The granting of this permit shall not be construed to in any way affect the title or ownership of property, and shall not make the Department of Environmental Protection or the State a party in any suit or question of property.
6. This permit does not waive the obtaining of Federal or other State or local government consent when necessary. This permit is not valid and no work shall be undertaken until such time as all other required approvals and permits have been obtained.

Failure to submit the certification within this time period may be grounds for revocation of the permit.

Section C. PERMIT EXPIRATION AND EXTENSIONS OF TIME

1. This permit shall remain in force for a period of only two years from the date of approval unless stated otherwise within the special provisos, or construction of said works has begun within the approved time frame. Interruption of construction of said works for a period of more than two years may serve as a basis for permit revocation.
2. Treatment works approvals may be extended beyond the original two year approval date, to a maximum of five years from the original issuance date, in accordance with the terms and conditions in N.J.A.C. 7:14A-22.12, unless stated otherwise within the special provisos. A time extension request must be received by the Department prior to the permit's expiration date. Requests must be submitted to the Bureau and address noted on the cover page.

Section D. ADJUDICATORY HEARING REQUESTS

1. Pursuant to N.J.A.C. 7:14A-22.24 et seq., any interested person who considers himself or herself aggrieved by this action, may, within 10 days of publication of notice of the decision in the DEP Bulletin, request a hearing by addressing a written request for such hearing to the:

Good Evening Jill:

This email serves to memorialize our conversation of last week regarding the Washington Township Municipal Utilities Authorities' ("MUA") responsibilities under the Patient and Protection Affordable Care Act ("ACA").

The ACA requires "applicable large employers," employing at least fifty (50) full-time employees, with an offer of health benefits coverage. A full-time employee is one who works at least 30 hours per week. An employer will be considered an applicable large employer if it employs 50 full-time employees or "full-time equivalent" employees. A full-time equivalent employee is one who may work part-time, but whose hours, when counted with other employees, equates to at least 30 hours per week. As such, in order to determine whether an employer is an applicable large employer, and therefore required to offer health benefits coverage to full-time employees, employers must calculate the hours of all its employees for a given month, not to exceed 120 hours per employee, and divide by 120 (hours). For example, an employer can only include in its calculation of full-time equivalent employees, 120 hours of an employee's monthly working hours, even if that employee worked 160 hours that month.

In addition to counting full-time and full-time equivalent employees, the ACA applies the aggregate employer rule, which looks at the amount of control one company has on an affiliate company, to determine whether both companies are deemed one applicable large employer. If two companies are considered one large employer, then both companies will be required to, among other requirements, provide an offer of health benefits coverage to employees working at least 30 hours per week. No statute, regulation, case or administrative decision could be found, however, that indicates whether government entities are subject to the aggregate employer rule. In fact, the U.S. Department of the Treasury, in the preamble to the final regulations governing employers' shared responsibility requirements under the ACA, indicated that:

The final regulations continue to reserve on the application of the employer aggregation rules under section 414(b), (c), (m) and (o) to government entities. . .

See 79 Fed. Reg. 29, p. 8548 (February 12, 2014). As such, in order to determine whether the MUA and Washington Township are deemed one applicable large employer, the level of control the Township has over the MUA must be assessed.

According to the information you provided, the MUA employs seven (7) full-time employees, three (3) part-time employees, and two (2) temporary employees. Although the MUA was established by Washington Township, it is separate and independent from the Township. The MUA reports its employees separately for purposes of unemployment benefits; it independently offers health benefits to eligible employees through the State Health Benefits Program ("SHBP"); and its accounting and billing operations are independent from the Township. Moreover, and according to the New Jersey Supreme Court, a municipal utilities authority is an independent instrumentality. See Browning-Ferris Industries of North Jersey, Inc. v. City of Passaic, 116 N.J. 83 (1989). Because the MUA does not employ 50 or more full-time or full-time equivalent employees, and because the MUA is independent from the Township, in that the Township does not control or operate the MUA and/or its services, the MUA is likely a small employer, and as such, does not have to comply with the ACA's shared employer responsibility requirements.

Nevertheless, as a small employer, the MUA must still comply with certain reporting and informational requirements. Specifically, under the Internal Revenue Code, Section 6055, all employers who provide health benefits to employees must provide to each full-time employee, by January 31st of the calendar year following the year in which benefits were provided, a written statement containing the information set forth in Form 1095C. See 26 U.S.C. 6056(c); and 26 C.F.R. 301.6056-1(f). (Form 1095C, which is still in draft form, is attached to this email for your review and reference.) The written statement requirement can be accomplished by providing the employee with a copy of the Form 1095C that pertains to him/her. Id. Extensions of time, not to exceed thirty (30) days, may be requested and granted for good cause shown. 26 C.F.R. 301.6056-1(g)(ii). Providing the written statement by first class mail to the employee's last known permanent address (or temporary address if lacking a permanent address) will satisfy the employer's obligation. Id. at (g)(2). Alternatively, an employer may electronically furnish the employee statement provided that it complies with procedural safeguards and requirements of the Treasury regulations. Employers must be sure to comply with the Department of the Treasury's electronic posting requirements.

In addition to the tax reporting requirements, small employers must also adhere to the Department of Labor's informational requirements. Pursuant to Section 18B of the Fair Labor Standards Act ("FLSA"), added by the ACA, employers must provide all employees, regardless of their part-time or full-time status, with written notice of their health benefits options, provided through the employer and/or through the Exchange. For purposes of this letter, this required notice will be referred to as the "18B Notice." You indicated that the MUA had already provided 18B Notices to employees. It is further recommended, that each new employee receive an 18B Notice, and return to the MUA, a signed copy for the employee's file. If the health benefits plan(s) offered by the MUA changes, or if the MUA amends its eligibility requirements, it is also recommended that new 18B Notices be issued to all employees, and that all employees return a signed copy to the MUA for their files. As discussed during our telephone discussions, I have attached a template 18B Notice for your review and reference.
