A review of the Tewksbury/MUA agreement for water connections for the Cleveland Industrial Center area determined that a provision in the agreement specified that no connection fee can be charged for the tie-in of the Sanctuary. Under the terms of the agreement, the DEP reimbursed the MUA for the cost for the actual connection. Since the DEP is no longer reimbursing the MUA for the actual connection material cost and labor, the physical cost related to the connection of the Sanctuary will need to be paid by the Church.
