#### DIRECTOR'S REPORT

- F. Platt advised the Board that he has a completely different relationship with J. Gregory and D. Egarian through his other employment at Rockaway Valley Sewage Authority. J. Gregory and D. Egarian represent Whitlock Packaging Corp. which currently sits on the other side of the table from F. Platt in his role at Rockaway Valley. Currently everyone is being very professional, but dealings through the WTMUA may be colored by the situation at Rockaway Valley. There may also be a perception of a conflict. This makes the transition to a new Executive Director more critical. It was agreed that F. Platt will bring any issues with regard to either J. Gregory or D. Egarian directly to the Board.
- The Compliance Inspection Report from DEP was provided. Most of the items have been addressed and there should be a positive outcome to this Report.
- AEA conference provided the following information:
  - The Governor wants to be involved in everything.
  - Government is slow to approve new legislation.
  - Many regulation deadlines are being extended.
  - There is no news on if, or what, changes may be made to the Highlands Council.
  - There is an effort to make extensive changes to the PERS system. Most local agencies are making their contributions. It is only the State that has not continued to make theirs.
  - AEA will oppose the Van Drew Bill which will allow the Mayor to veto actions by the MUA Board.
  - Currently in the process of getting competitive quotes for the work for Well 3 and 18 as required by the NJ Purchasing Laws. There will be no action on the Technical Components quote that was distributed at the last meeting until that is complete.

- The Geosciences Services quotations will be discussed at the next meeting when J. Gregory is available.
- Highlands Council has provided sewage system mapping that needs to be reviewed. A water system map has been requested.
- An email was circulated from the Office of Emergency Management (OEM) advising that there is a module available through Morris County for emergency notification. A meeting will be held with all applicable offices to ensure that the program is implemented correctly and everyone notified of the program. The system shortcoming is that it only notifies Verizon and Centurylink landline phones. Possible solution is to add to WTMUA Rules and Regulations that customers need to provide emergency contact information as well as email addresses. Then this information has to be input into our system. A request to confirm contact information can be sent every year with the Water Quality Report. It is unclear if supplemental information can be added to the County system.
- Met with the School Board. A credit is due to Kossman for the meter head issue that over-registered their use.
- USEPA is doing further studies on groundwater contamination in the Old Farmer's Rd., Fairmount Rd. and Parker Rd. areas. Information was provided on the MUA service in that area.
- Grove Street site plans should be completed shortly. Will need to set up a meeting with the Township.
- Mailed seven notices in conjunction with the WT Health Department to advise the residents that they are now permitted to hook into the WT MUA sewer system. The Highlands has advised that any additional requests will have to wait until there is accurate mapping of the system.

#### GIS MAPPING

GIS mapping has been required by NJDEP going back two years. They will not allow any additional water service connections within the Township until the mapping is provided. The Grove Street project can proceed because it was ordered by the State. The original vendor has been non-responsive. The mapping that was provided by the Highlands Council only provides the properties served, which is one of the five DEP requirements. It does not provide the piping and facilities.
